A motion was made by Stotz and seconded by Mushitz to approve the Prisoner Housing Agreements with Aurora, Bennett, Bon Homme, Douglas, Faulk, Gregory, Hand, Hanson, Hutchinson, Hyde, Jerauld, Kingsbury, Lincoln, McCook, Mellette, Miner, Minnehaha, Moody, Spink, Turner and Union Counties at the rate of \$65.00 each prisoner each day. All in favor, motion carried

Highway Superintendent:

Doug Kniffen met with the Commission. Weight Limits were discussed. A motion was made by Mushitz and seconded by Stotz to pass the Resolution of Weight Limit Enforcements on Charles Mix County Highways. All in favor, motion carried. Also discussed was the purchase of a used track skid steer. A motion was made by Stotz and seconded by Mushitz to approve the purchase of a 2017 John Deere 323E Compact Track Loader for \$49,950.00 with and extended warranty for the price of \$2,564.00. All in favor, motion carried.

Weight Limit Enforcements:

A motion was made by Mushitz and seconded by Stotz to pass the Resolution of Weight Limit Enforcements of Charles Mix County Highways for 2019. All in favor, motion carried.

A Resolution of Weight Limit Enforcements on Charles Mix County Highways

WHEREAS, a seasonal climatic changes can be detrimental to our highways, and State Laws SDCL 32-14-6 gives the county the authority to prohibit the operation of vehicles or restrict weight of vehicles upon any highway under its jurisdiction, by reason of deterioration of physical condition, rain, snow, or other climatic conditions will seriously damage or destroy unless the use of vehicles on the highway is prohibited or the permissible weights of the vehicles are reduced; and

WHEREAS, by State Law SDCL 32-22-24, Spring Load Limits may be put on as early as February 15 and may stay on through April 30. Time of Implementation and removal is dependent on weather and road conditions. Limits become effective when the signs are installed and displayed an are no longer enforceable when they are removed; and

WHEREAS, the tax payers bear the burden of the costs of road repair;

WHEREAS, the Board of Charles Mix County Commissioners, desires the enforcement of weight limitation of Charles Mix County Roads as set forth and posted by the Charles Mix County Highway Superintendent.

NOW THEREFORE BE IT RESOLVED: The limits on Charles Mix County Highway shall be set as seven (7) ton per axle, on designated roads during spring thaw period and when signs are in place; and

That the South Dakota Highway Patrol is hereby authorized and requested to enforce weight limitations on Charles Mix County Roads.

BE IT FURTHER RESOLVED that the penalty for the violation of the load restrictions shall be set forth in SDCL 32-22-55.

Sheriff Randy Thaler:

Sheriff Randy Thaler met with the Commission to discuss 2019 starting wages and shift differential page for Law Enforcement employees. A motion was made by Stotz and seconded by Mushitz to approve a shift differential pay of \$0.50/hour for employees working between 6 pm and 6 am. All in favor, motion carried. A motion was made by Mushitz and seconded by Stotz to approve a salary adjustment for Sheriff Randy Thaler of \$4,160.00 for 2019. All in favor, motion carried.

Law Enforcement Contract:

Discussion was held on the Agreement for Law Enforcement Services between the City of Lake Andes and Charles Mix County in the amount of \$108,000 per year commencing January 1, 2019 to December 31, 2019 for said law enforcement services.
