Charles Mix County Board of Equalization April 25, 2019

The Charles Mix County Board of Equalization met in regular session on April 25, 2019 at 1:00 pm. Chairman Nick Stotz called the meeting to order with Commissioner Neil Von Eschen present. Also present was Director of Equalization, Denise Weber and Auditor, Sara K. Clayton.

Agenda:

A motion was made by Von Eschen and seconded by Stotz to approve the Agenda as presented. All in favor, motion carried.

Minutes:

A motion was made by Von Eschen and seconded by Stotz to approve the minutes from the April 9, 2019 meeting. All in favor, motion carried.

Omitted Property:

The following notices of intention to add omitted property were presented to the Board:

- 1. Duck Inn Waddle Out Bar LLC; Lot 9, Blk 1; OL "A" Track; City of Lake Andes. A motion was made by Stotz and seconded by Von Eschen to add the property to the tax roll for the 2018 assessment year for 10 months, with a prorated value of \$1,066. All in favor, motion carried.
