Disabled Veteran Property Tax Exemptions:

A motion was made by Stotz and seconded by Soukup to approve all 20 parcels that qualify for the Disabled Veteran Property Tax Exemptions (SDCL 10-4-40). All in favor, motion carried. Let it be noted that Commissioner-Mushitz chose to abstain from the vote.

A motion was made by Mushitz and seconded by Stotz to send notice to property owners that the board intends to add omitted properties to the tax roll.
