The Charles Mix County Board of Commissioners met in regular session on the 10th of June 2021 at 10:00 am. Chairman – Nick Stotz opened the meeting with the Pledge of Allegiance and called the meeting to order with Vice-Chairman – Keith Mushitz, Commissioner – Colin Soukup, and Auditor – Danielle Davenport present.

Agenda:

A motion was made by Soukup and seconded by Mushitz to approve the agenda as presented. All in favor, motion carried.

Minutes:

A motion was made by Soukup and seconded by Mushitz to approve the minutes from the May 20^{th} , 2021 meeting. All in favor, motion carried.

A motion was made by Mushitz and seconded by Soukup to approve the bills for 6/3/2021. All in favor, motion carried.

Drainage Work Order/Proposal:

The Drainage Study Proposal from Brosz Engineering, concerning area west of Wagner, was presented. Discussion was held between the Commission and Hwy Superintendent-Cimpl regarding cost and priority. No action taken at this time, further discussion to be held at the 6/17/2021 meeting.

Personnel:

Cimpl informed the Commission of personnel changes. A motion was made by Soukup and seconded by Mushitz to approve the hiring of Duane Funk for the Crewman position in the Wagner Shop at a rate of \$14.00 per hour with a starting date of 6/8/2021. All in favor, motion carried.

Approach:

The Commission advised Cimpl that the Bud Koupal approach project that was approved at the 5/20/2021 meeting has been rescinded. Cimpl was informed that there is currently access to the land with three other approaches in place. Any work approved and completed by the county will be at the cost of the landowner. No further action taken.

Surplus:

A motion was made by Mushitz and seconded by Soukup to surplus the Highway Department's CASE IH, Farm 140A, Tractor 2WD and CIH Farmall 140A T4B Mower from the Platte Shop. No action taken on the topic of resale at this time. All in favor, motion carried.

DOT Agreement:

Cimpl presented Amendment Number 2 to Agreement Number 614996 regarding projects ER6165(04) and ER6198(05). The parties, having previously amended the Agreement to adjust the limiting amount for certain damaged County highways, wish to further amend the Agreement to adjust the limiting amount for certain damaged County highways from the 2019 flooding. A motion was made by Mushitz and seconded by Soukup to approve the amended agreement and have Chairman-Stotz sign. All in favor, motion carried.

County Property:

Bennett was not present regarding his parcel and an adjacent County parcel. States Attorney – Steve Cotton was present to provide a Quit Claim Deed for Charles Mix County property - Lot One (1) and all that part of the Southwest Quarter of the Northwest Quarter (SW1/4NW1/4) of Section Eleven (11), in Township Ninety-six (96) North, of Range Sixty-Five (65), West of the 5th P.M., lying north of the Railway Right of Way of the Chicago, Milwaukee and St. Paul & Pacific Railway Company, as now located and established. A motion was made by Mushitz and seconded by Soukup to approve the Quit Claim Deed to Theresa Chytka and William Bennett and have Chairman-Stotz sign the deed. All in favor, motion carried.

Executive Session:

A motion was made by Soukup and seconded by Mushitz to enter into executive session at 10:48 am to discuss personnel matters with States Attorney – Steve Cotton and Auditor-Davenport present. All in favor motion carried. An end was declared to executive session at 11:05 am with no action taken.

Public Hearing Ordinance 2021-01:

Chairman-Stotz announced this to be the time and place for a public hearing and conducted the first reading of Charles Mix County Ordinance 2021-01. Commission discussion was deferred until the second reading on 6/17/2021 at 10:00 am in the Commissioner room at the Charles Mix County courthouse in Lake Andes, SD. No public comments were heard at this time.

CHARLES MIX COUNTY ORDINANCE 2021-01 A TEMPORARY ORDINANCE REGARDING THE ISSUANCE OF LOCAL MEDICAL CANNABIS ESTABLISHMENT PERMITS AND/OR LICENSES.

WHEREAS, a local government may enact an ordinance not in conflict with SDCL Chapter 34-20G, governing the time, place, manner, and number of medical cannabis establishments in the locality. A local government may establish civil penalties for violation of an ordinance governing the time, place, and manner of a medical cannabis establishment that may operate in the locality. A local government may require a medical cannabis establishment to obtain a local license, zoning permit, or registration to operate, and may charge a reasonable fee for the local license, zoning permit, or registration.

WHEREAS, Charles Mix County, South Dakota ("County"), makes a preliminary finding that the County's current regulations and controls may not adequately address the unique needs and impacts of medical cannabis establishments as defined in SDCL 34-20G-1;

WHEREAS, medical cannabis state laws under SDCL 34-20G are effective July 1, 2021, with the South Dakota Department of Health is required to promulgate rules pursuant to chapter 1-26 no later than October 29, 2021, as defined by SDCL 34-20G-72. During the time between July 1, 2021 and potentially as late as October 29, 2021, local units of government, such as Charles Mix County, will not yet know standards for medical cannabis and will not be able to adequately assess the local zoning and licensing requirements necessary to approve local permits and to better ensure applicants have a more predictable permitting process and avoid stranded investments.

WHEREAS, the County makes a preliminary finding that the County needs further study of the relationship of medical cannabis establishments to the County's desire and need to protect the community. The public interest requires that the County study, analyze, and evaluate the impacts of medical cannabis establishments and to fully explore the impacts of any proposed regulations regarding medical cannabis establishments;

WHEREAS, the County makes a preliminary finding that it would be inappropriate for the County to issue a local permit or license to a medical cannabis establishment prior to the South Dakota Department of Health's promulgation of regulations governing the same;

WHEREAS, the County hereby exercises its authority under SDCL 11-2-10 and SDCL 7-18A-8, to establish a temporary ordinance regarding he issuance of any local permits/licenses for medical cannabis establishments within the County;

WHEREAS, a temporary ordinance will ensure that more comprehensive regulations and ordinances for issuing licensing permits, can be completely examined with adequate public input from citizens, business interests, and medical cannabis industry representatives;

WHEREAS, the County finds that a temporary ordinance is reasonable to preserve the status quo and prevent significant investment pending the outcome of the above study and any proposed regulations or ordinances emanating therefrom;

WHEREAS, the County finds that the following ordinance is necessary to protect and immediately preserve the public health, safety, welfare, peace and support of the county government and its existing public institutions;

NOW, THEREFORE, BE IT ORDAINED BY CHARLES MIX COUNTY, SOUTH DAKOTA THAT:

Section 1. Temporary Ordinance – Application for Local Permit/License

A medical cannabis establishment desiring to operate in the County shall be required to apply for a permit and/or license from the County. Applications for a local permit and/or license to operate a medical cannabis establishment, as defined by SDCL 34-20G-1, shall not be accepted until the South Dakota Department of Health has promulgated regulations as required by SDCL 30-20G-72. Any application received prior to such regulations being promulgated shall be denied.

Section 2. Immediate Effect.

This ordinance is necessary to protect and immediately preserve the public health, safety, welfare, peace, and support of the county government and its existing public institutions pursuant to SDCL 11-2-10 and SDCL 7-18A-8. Second Reading to be held 6/17/2021 at 10:00 am.

Extra Territorial Jurisdiction:

Jeff and Jolene Stewart met with the County Commission to discuss the Extra Territorial Jurisdiction (ETJ) regarding the City of Wagner and provided their proposal for the County's consideration. The Commission has deferred the matter to Deputy States Attorney – Craig Parkhurst and will be provided with all materials. No action taken at this time.

Resolution:

Director of Equalization – Denise Weber was present with Resolution 2021-07. A motion was made by Mushitz and seconded by Soukup to approve Resolution 2021-07 and have Chairman-Stotz sign. All in favor, motion carried.

Charles Mix County County Resolution No. 2021-07 Discretionary Formula SDCL 10-6-137

WHEREAS, the County of Charles Mix, State of South Dakota has deemed it in the best interest of the County to adopt a Resolution implementing a Discretionary Formula for the reduced taxation of new structures and additions and partially constructed structures pursuant to SDCL 10-6-137.

NOW, THEREFORE, BE IT RESOLVED, that the following properties shall be, and hereby are, specifically classified for the purpose of taxation pursuant to SDCL § 10-6-137:

- 1.) Any new nonresidential agricultural structure, or any addition to an existing structure, if the new structure or addition has a full and true value of ten thousand dollars or more (SDCL § 10-6-137(3)); and
- 2.) Any new commercial structure, or any addition to an existing structure, except a commercial residential structure as described in SDCL \S 10-6-137(5), if the new structure or addition has a full and true value of thirty thousand dollars or more (SDCL \S 10-6-137(4)); and be it

FURTHER RESOLVED, that any structure classified pursuant to this Resolution shall, following construction, initially be valued for taxation purposes in the usual manner, and that value shall be referred to in this Resolution as the "Pre-Adjustment Value"; and be it

FURTHER RESOLVED, that the assessed value to be used for tax purposes of any structure classified pursuant to this Resolution shall, following construction, be calculated as follows:

- a. For the first tax year following construction, 20% of the Pre-Adjustment Value;
- b. For the second tax year the following construction, 40% of the Pre-Adjustment Value;
- c. For the third tax year following construction, 60% of the Pre-Adjustment Value;
- d. For the fourth tax year following construction, 80% of the Pre-Adjustment Value;
- e. For the fifth tax year following construction, 100% of the Pre-Adjustment Value;

and be it

FURTHER RESOLVED, that the Board of County Commissioners may, if requested by the owner of any of the above described property, not apply the above formula, in which case the full assessment shall be made without application of the formula. In waiving this formula for the structure of one owner, the Board of County Commissioners is not prohibited from applying the formula for subsequent new structures by that owner; and be it

FURTHER RESOLVED, that for purpose of this Resolution, the assessed valuation during any of the five years may not be less than the assessed valuation of the property year preceding the first year of the tax years following construction; and be it

FURTHER RESOLVED, that any structure that is partially constructed on the assessment date may be valued for tax purposes pursuant to this Resolution and the valuation may not be less than the assessed valuation of the property in the year preceding the beginning of construction; and be it

FURTHER RESOLVED, that anyone who builds an agricultural building with a value of ten thousand dollars or more or any commercial building with a value of thirty thousand dollars or more will forfeit their discretionary exemption if any such building(s) is constructed without first obtaining a building permit.

FUTHER RESOLVED, that following the five-year period under this section, the property shall be assessed at the same percentage as is all other property for tax purposes.
