Regular Session – July 14, 2022

The Charles Mix County Board of Commissioners met in Regular Session at the County Courthouse on Thursday, July 14, 2022. Vice Chairman Colin Soukup opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Commissioner Keith Mushitz and Auditor Jason Gant present with Chairman Nick Stotz absent.

Agenda:

A motion was made by Mushitz and seconded by Soukup to approve the agenda. All in favor, motion carried.

Minutes:

A motion was made by Mushitz and seconded by Soukup to approve the minutes from the June 23, 2022, Board of Commission regular meeting and to approve the minutes from the July 7, 2022, Board of Commission special meeting. All in favor, motion carried.

Bills:

A motion was made by Mushitz and seconded by Soukup to approve the bills for July 14, 2022. All in favor, motion carried.
